- i. M/S VENCEL DEVELOPERS (Prop. Mrs Rupali Dabre) have completed 46%* of the project titled (Vencel Enclave) MahaRERA Regn. No. <u>P99000009749</u> located at <u>Village Juchandra Taluka Vasai-District-Palghar</u>, <u>Pin-401208</u>
 - *As per engineer certificate dated 23 Mar 2018 from Sanjay Narag, Registered Engineer, the project is 46% completed in proportion to estimated cost and cost incurred based on estimate.
- ii. Amount collected during the year i.e. 1st July 2017 to 31st Mar 2018 for this project is 70% Rs. 17,01,000/- (100% amount is Rs.29,30,000) and amounts collected till 31st Mar 2018 is Rs. 2,01,54,826/-

Out of the above Rs. 29,30,000/- the amount of Rs.500,000/- pertains to sales made prior to RERA registration and not deposited in RERA designated Bank Account, however, the amount is utilized for the project.

- iii. Amount withdrawn during the year i.e. 1st July 2017 to 31st Mar 2018 for this project is 70% Rs. 1701000/- (100% amount is Rs.29,30,000/-) and amount withdrawn till 31st Mar 2018 is Rs. 2,01,54,826/-**
 - ** This amount includes Rs.1,72,24,826/- incurred for the project before the registration under MahaRERA, which is "Lower of total Project Cost incurred or the collection from the allottees on the date of registration of the project with MahaRera, as per circular no.7/2017 dated 4th July 2017.
