#### GENERAL TERMS AND CONDITIONS APPILCABLE TO THE APPLICATION FOR ALLOTMENT OF RESIDENTIAL UNIT IN

### "SRNR DAFFODIL"

- The Applicant(s) has / have applied for provisional allotment of a residential unit with full knowledge of the law/notification and rules applicable to this area in general and this project in particular which have been explained by SRNR Construction LLP. ( "the Company") and understood by him/her/them. The Applicant(s) further agree that the application becomes valid only upon the realization of the booking amount as accompanied by the booking Cheque / Demand Draft / RTGS. If any which has to be borne by the applicant.
- 2. It is clear agreed and understood that upon execution of the Sale Agreement of Sale the terms and conditions contained therein shall supercede these terms and conditions set out in this Application. The Sale shall be executed after receipt of the entire consideration towards undivided share in land and about 80 % of the Cost of Construction under the Construction Agreement. The Applicant(s) agree and accept that the actual physical possession of residential unit shall be handover to the Applicant(s) only after the receipt of total consideration and all other payments and due execution and registration of the Sale Deed.
- 3. In case, before the signing of the Agreements for Sale Agreement or 45 days from Booking, whichever is earlier, the Applicant(s) seeks cancellation of the booking, an amount of Rs 70,000 for 3 BHK Type Apartment, Rs 50,000 for 2 BHK Type Apartment, will be deducted as cancellation fee by the Company and the balance amount without any interest, will be refunded within 30 days from the date of receipt of cancellation form in the prescribed format, duly signed by the applicant. The company has the right to cancel the residential unit allotment and refund the amounts paid, with applicable cancellation charges and without any interest, at any time before entering into the Agreement for Sale and Construction.
- 4. No change is allowed in the names of the Applicant(s). All correspondence / receipts / allotment shall be in the name of the First Applicant only, at the address/ communication details provided for booking and it shall be his/her/their responsibility to inform the Company by means of registered letter/e-mail about the subsequent changes in his/her/their address. The Applicant(s) shall be responsible for any default in payment and / or other consequences that occur therefrom. Transfer/Sale/Nomination of residential unit to a third party by the Applicants(s), before handover will be subject to the Company's consent in writing, and execution of necessary Construction Agreement and Agreement for Sale between the Company and the New Applicant(s), as per transfer policy of the Company.
