4. Walls: External 6 inches Internal 4 inches
5. Common Areas: Good quality flooring tiles.
6. Doors: Main door frame will be Teak wood with Flush door shutters
7. And internal bedroom frame will be of sal wood and flush door shutters.
8. Windows: Powder Coated Aluminum Glazed windows.
