- 6. The Promoter shall get the accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the take all project.
- 7. **The Promoter** shall take the pending approvals on time, from the competent authorities.
- 8. **The Promoter** shall inform the Authority regarding all the changes that have occurred in the information furnished under sub-section (2) OD section 4 of the ACT and under rule 3 of these rules, within seven days of the said changes occurring.
- 9. **The Promoter** have furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 10. **The Promoter** shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
