- (c) Obtain Occupancy Certificate from the Corporation.
- (d) Permit authorized officers of the Corporation to enter the building or premises for which the permission has been granted , at any time for the purpose of ensuring the building control Regulations and conditions of this certificate.

- 10. The conditions of this certificate shall be binding not only on the applicant but also on its successors and/or every person deriving title through or under him.
- 11.A certified copy of the approved plan shall be exhibited on site.
- ^{12.}The amount of **Rs 2,000.00/-** deposited with CIDCO as security deposit shall be forfeited either in whole or in part at the absolute discretion of the Corporation for breach of any of the conditions attached to the permission covered by the Commencement Certificate. ii) All three star or higher category hotels.

To establish a dedicated Solid waste management system to treat 100% wet waste being

generated in such buildings. The treatment of wet waste shall be done through an organic waste

composters/ vermiculture pits or other similar technologies of suitable capacity installed

through reputed vendors. The disposal of dry waste, e-waste, hazardous waste shall be carried

out through authorised recyclers or any other system as specified by the Authority.

17. As per Regulation no. 13.3 of UDCPRs following additional condition of Rain Water Harvesting

shall apply.

a) All the layout open spaces/amenity spaces of housing societies and new constructions/

reconstruction/ additions on plots having area not less than 500 sq mt shall have one or

more Rain Water Harvesting structures having a minimum total capacity as detailed in

Schedule. Provided that the Authority may approve the Rain Water Harvesting structures of

specifications different from those in Schedule, subject to the minimum capacity of Rain

Water Harvesting being ensured in each case.
