- 2. The applicant shall :-
 - (a) Give a notice to the Corporation for completion of development work upto plinth level, at least 7 days before the commencement of the further work.
 - (b) Give written notice to the Corporation regarding completion of the work.
 - (c) Obtain Occupancy Certificate from the Corporation.

shall apply.

a) All the layout open spaces/amenity spaces of housing societies and new constructions/

reconstruction/ additions on plots having area not less than 500 sq mt shall have one or

more Rain Water Harvesting structures having a minimum total capacity as detailed in
