- 3. We estimate Total Estimated Cost of completion of the building(s) of the aforesaid project under reference as <u>Rs. 6,58,95,420/-</u> (Total of Table A and B). The estimated Total Cost of Project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate/completion certificate for the building(s) from the <u>Ahmedabad Municipal Corporation</u> being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.
