- 2. That the revised structural design/calculations/details/drawings shall be submitted before endorcement of C.C.
- That payments towards following shall be made before asking for C.C.
  - a) Premium towards labour welfare cess.
  - b) Development charges
  - c) Open Space Deficiency Premium
  - d) Premium for inadequate size of Artificial ventilation shaft
- 4. That the final N.0 C. from C.F 0 shall be submitted before asking for Occupation permission.
- 5. That the cc shall be got endorsed as per the amended plan.
- 6. That the work shall be carried out strictly as per approved plan.
- 7. That the final structural stability certificate shall be submitted before asking for B.C.C.
- 8. That the supervision certificate shall be submitted periodically from the L.S. Engineer Structural Engineer / Supervisor or Architect as the case may be as per D.C.Reg.5(3)(ix) regarding satisfactory construction on site.
- 9. That all the conditions stipulated in the order of Hon. Supreme Court of India dated 15.03.2018 in the Dumping Ground Case shall be complied with.
- 10. That adequate safeguards be employed in consultation with SWM Dept. of MCGM for preventing dispersal of particles through air and construction debris generated shall be deposited in specific sites inspected and approved by MCGM.

- 11. That the debris shall be managed in accordance with the provisions of Construction and Demolition Waste Management Rules 2016.
- 12. That the drainage layout shall be revised before carrying out further drainage work

- 17. That the Registered Undertaking for swimming pool shall have re-circulation and filtration equipment provided for water purification shall be submitted before further C.C.
- 18. The payment as per schedule of installment granted by Dy.Ch.Eng.(B.P) City shall be made
- 19. That the NOC from MHADA for splitting and amalgamation of tenements shall be submitted before asking for further CC.
- 20. That the elevations features shall not be misused and Registered Undertaking to that effect shall be submitted.
- 21. That the structural stability certificate for Mechanised Puzzle Parking Systems shall be submitted before further C.C.
