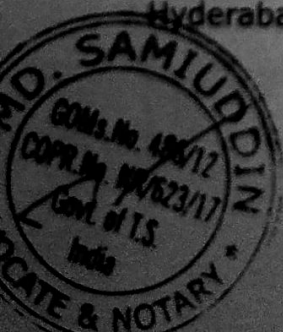
That details of encumbrances including details of any rights, title, interest or name of any party i or over such land , along with details.

4.
