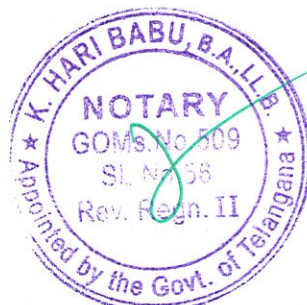

2. That the said land is free from all encumbrances.
