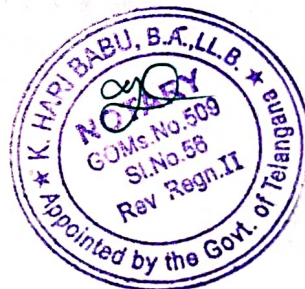
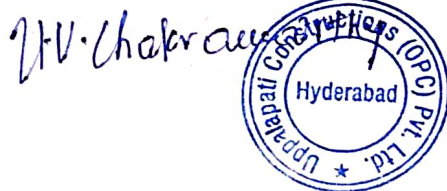

6. That the amounts from the separate account shall be withdrawn after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.

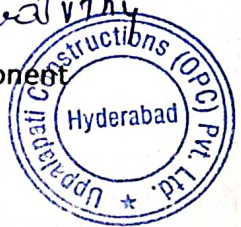

8. That I/promoter shall take all the pending approvals on time, from the competent authorities.

9. That I/the promoter have/has furnished such other documents as have been prescribed by the rules and regulations made under the Act.

10. That I/The promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.

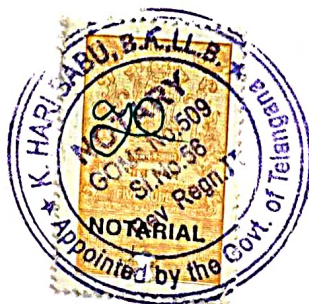
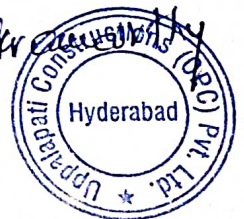
