I, Aluri Ramachandra Rao S/o A Venkateswarlu Chowdary promoter of the proposed project do hereby solemnly declare, undertake and state as under:

1. 8. That I/promoter shall take all the pending approvals on time, from the competent authorities.
9. That I / promoter have / has furnished such other documents as have been prescribed by the rules and regulations made under the act.
