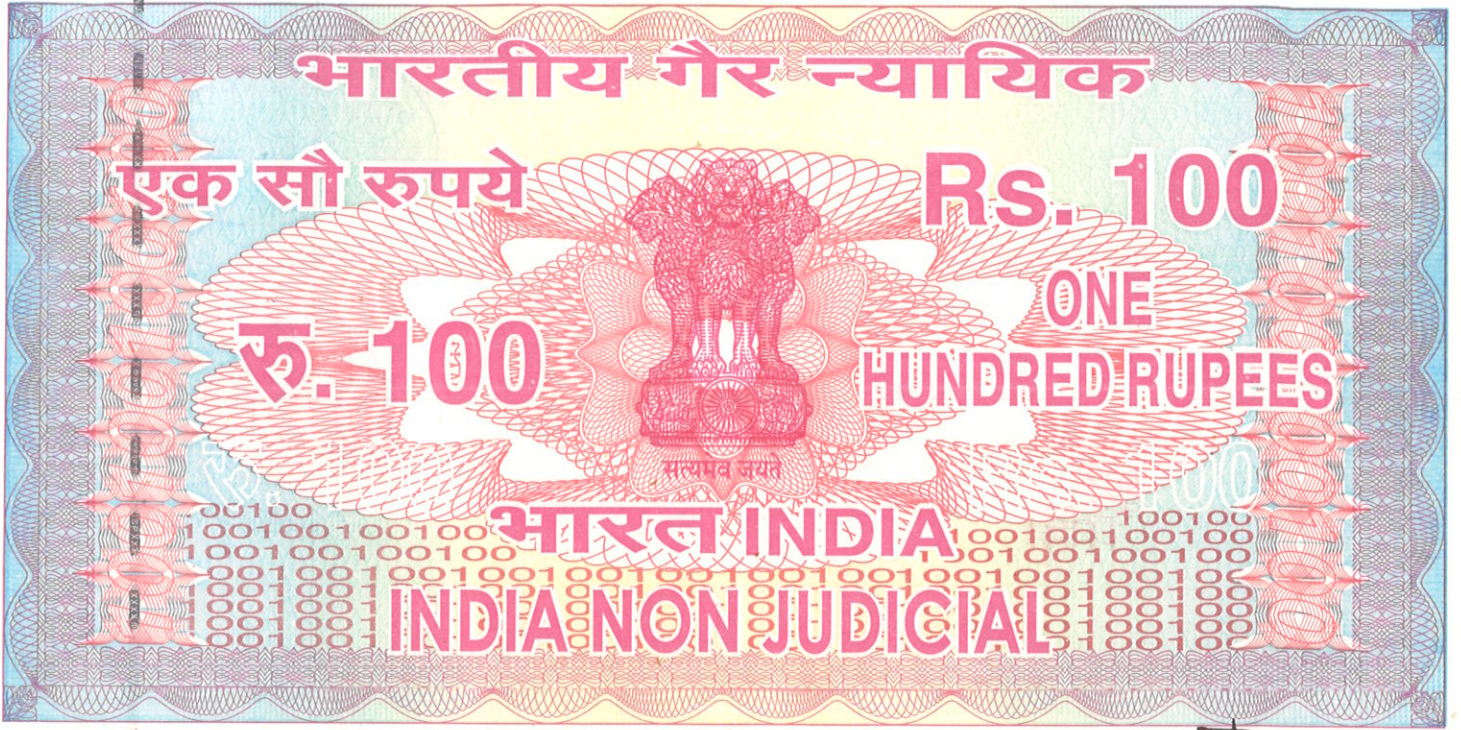

5. That the amounts from the separate account shall be withdrawn in accordance in proportion to the percentage of completion of project

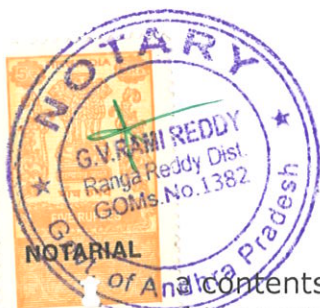

9. That I have / has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
