The Tentative Layout Permission in Sy.No. Sy.No's- 63/A,64,65/A,81/AA,82/AA,83/AA,84/AA,85,86,87,88/A,88/AA,89& 91 situated at Old Ramachandrapuram, Sangareddy Dist. to an extent of 20737.8 Sq.mts belonging to M DEVENDER RAJU is hereby approved subject to following conditions:

Draft Letter Conditions

- 1. The mortgaged (registered) 15% of plotted area to GHMC which will be released only after development of layout as per the approved plan with proper infrastructure as per the norms / specification of Engineering Section of GHMC.
- 2. To construct the Septic tank as indicated in the plans before release of final layout.
- 3. The applicants to form all roads with BT and shall develop the Layout with Underground drainage, Street lighting, Avenue plantation before obtaining final layout.
- 4. The applicant shall construct compound walls to all layout open spaces and social infrastructure shall develop with facilities before release of final layout
- 5. The applicant shall handover the areas covered under roads, open spaces and social infrastructure to GHMC through a Registered Gift Deed before release of Final Layout.
- 6. This communication does not confirm and right of sale(OR) allotment of the plots
- 7. That no structures are to be allowed in the layout open space.

Additional/Other

- 1. The 15% of Layout Plot Nos. 66, 67, 70, 71, 72, 73, 74, 75, 76, 77, 78 & 79 (total 12 plots) admeasuring 1556.60 Sq. Mts (or) 1861.66 Sq.yards which are mortgaged to the Commissioner, GHMC vide Document no.23040/2021 Dt: 23/06/2021, will be released only at the time of issue of Final Layout.
- 2. The 5% of Layout Plot Nos. 64, 65, 68 & 69 (total 4 plots) admeasuring 518.66 Sq. Mts (or) 620.32 Sq.yards which are mortgaged to the Commissioner, GHMC vide Document no.23041/2021 Dt: 23/06/2021, will be released only after remittance of Post dated cheques submitted towards fees / charges through installments.
- 10% of open space, Master plan road and 40'-00" wide road shall be handed over to GHMC free of cost by Registered Gift deed before release of the layout.
