OBSERVATIONS

- 1. - 5. However by way of caution I made a search in the above website and found no litigation involving the name of the Owners, I advise that a sworn affidavit may be taken from the applicant confirming that there are no litigations pending over the property.
- 6. I have also made search of form 22 Registrar, the above Scheduled property does not fall under the Prohibited properties.
