- 3. That the time period within which the project shall be completed by [me / the promoter] is 25/02/2025.
- 4. That seventy per cent. of the amounts realized by [me / the promoter] for the real estate project from the allotters, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
