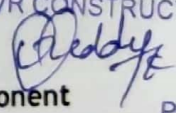

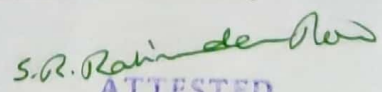
3. That the time period within which the project shall be completed by [me / the promoter] is 15/09/2025.
4. 10. That [I / the promoter] shall not discriminate against any allotted at the time of allotment of any apartment, plot or building, as the case may be.

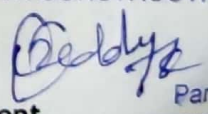
