ORDER

Sanction is accorded from HMDA to Sri Devender Raju S/o M Jaipal for constructions of Residential Apartment (1 Still+5 Upper floors) as per Technical approved plan by Metropolitan Commissioner, HMDA, Secunderabad Reference cited in Sy No. 687 Open Plot in Ameenpur Village Grampanchayat Ameenpur Subject to the following conditions.

Conditions:-

1. The permission is valid for three years from the date of issue of permission by HMDA. If the building is constructed or not completed within stipulated period the permission will be lapsed.
2. Application for renewal of the permission failing which the permission will be treated as a fresh case.
3. The permission holder should provide the sanction plan and the permission for the personal verification when demanded by the inspecting authorities failing which the construction will be deemed as unauthorized and action will be taken under provision of AP GP Act 1994.
4. The permission holder should not do any work other than in accordance with the sanction plan and any direction of requisition made subsequently.
5. This permission will neither establish the owner ship nor directed to the owner ship of the land.
6. The permission accordance not bar the ownership of application on other provision of AP GP Act 1994.
7. After completion of Buliding the owner/Developer must be intimated to this office and obtain occupancy certification without fail other wise it will be fined according to rule.
