- That the PROMOTER has a legal title Report to the Project Land, on which the

 legally valid authentication of the title of such project land along with an
 authenticated copy of the agreement between such owner society and
 promoter for redevelopment of the Real Estate Project, is enclosed herewith.

That the PROMOTER shall get its accounts audited within six months after the end of every financial year by a practicing Chartered Accountant, and shall produce a statement of accounts duly certified and signed by such practicing Chartered Accountant, and it shall be verified during the audit that the amounts collected for the Real Estate Project have been utilized for the Real Estate Project and the withdrawal has been in compliance with the proportion to the percentage of completion of the Real Estate Project.
- That the PROMOTER shall take all the pending approvals on time, from the competent authorities.
