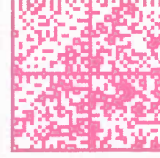

**Affidavit cum Declaration**

Affidavit cum Declaration of M/s. MY ENVIRE DEVELOPERS Pvt. Ltd Rep. by its Managing Director Mr. Nallapu Prem Sagar Reddy [promoter of the project / duly authorised by the promoter of the project, vide its/his/their authorisation dated 12-12-2017];

I, Mr.N.PREM SAGAR REDDY Managing Director of M/s MY ENVIRE DEVELOPERS Pvt.Ltd do hereby solemnly declare, undertake and state as under:

1. M/s MY ENVIRE DEVELOPERS Pvt.Ltd have a legal title to the land on which the development of the proposed project is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

2. That the said land is free from all encumbrances.

Or

That details of encumbrances \_\_\_\_\_ including details of any rights, title, interest, dues, litigation and name of any party in or over such land.

3. That the time period within which the project shall be completed by the promoter is 27<sup>th</sup> April 2024.

4. That seventy per cent. Of the amounts realized by the promoter for the real estate project from the allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the promoter in proportion to the percentage of completion of the project.

6. That the amounts from the separate account shall be withdrawn by the promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.



7. That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

8. That the promoter shall take all the pending approvals on time, from the competent authorities.

9. That the promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made there under.

10. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
