The Commencement Certificate / Building Permit is granted subject to compliance of mentioned in LOI U/R No_SRA/ENG/864/PL & STGL/LOI dt 05/03/2021 IOA/U/R No_R-C/PVT/0003/20040220/AP/S3 dt 23/01/2023 and on following conditions.

The land vacated in consequence of endorsement of the setback line / road widening line shall from part
of the Public Street.

 That no new building or part thereof shall be occupied or allowed to be occupied or used or permitted to be used by any reason until occupancy permission has been granted.

3. The Commencement Certificate / Development permission shall remain valid for one year from the date of its issue. However the construction work should be commenced within three months from the date of issue.

4. This permission does not entitle you to develop land which does not vest in you or in contravention of the provision of coastal Zone Management Plan.

If construction is not commenced this Commencement Certificate is renewable every year but such extended period shall be in no case exceed three years provided furher that such lapse shall not bar any subsequent application for fresh permission under section 44 of the Maharashtra Regional and Town Planning Act. 1966.
 This Certificate is liable to be revoked by the C.E.O. (SRA) if:-

(a) The development work in respect of which permission is granted under this certificate is not carried out or the use thereof is not in accordance with the sanctioned plans.

(b) Any of the condition subject to which the same is granted or any of the restrictions imposed by the C.E.O. (SRA) is contravented or not complied with.

The C.E.O. (SRA) is satisfied that the same is obtained by the applicant through fraud or misrepresentation and the applicant and every person deriving title through or under him in such an event shall be deemed to have carried out the development work in contravention of section 43 and 45 of the Maharashtra Regional and Town Planning Act 1966.

The conditions of this certificate shall be binding not only on the applicant but on his heirs, executors, assignees, administrators and successors and every person deriving title through or under him.
