- 4) That the extra water and sewerage charges as per the amended plan shall be paid to A.E. (WW) 'R/S' before F.C.C.
- That all the balance payments as per the amended plan shall be paid before F.C.C.
- 6) That the Dry and Wet garbage shall be separated and the wet garbage generated in the building shall be treated separately on the same plot by the residents/ occupants of the building.
- That the Material testing report shall be submitted.
- 8) That the one time PCO charges shall be paid.
- 9) Monthly progress report shall be submitted.
- 10) That the all conditions mentioned in amended plan approved time to time shall be compiled with.
- 11) That no dues pending certificate from AEWW R/South shall be submitted
- 12) That valid Janata Insurance policy shall be submitted.
- 13) That valid SWM NOC shall be submitted.
- 14) That every year before onset of the monsoon / revalidation of C.C., structural stability certificate of the work executed on site shall be submitted by the appointed Registered Structural Engineer / Consultant, appointed by owner / occupier / society.
