of the order of Rs.500/- (Rupees five hundred only) shall

purchaser. Now I myself or my heirs, successors, and



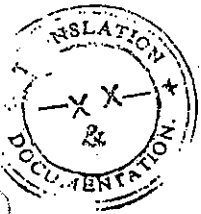

That I have executed and completed this sale deed only of my free will and without any pressure, force or coercion and after giving full thought to it and in future none of my heirs or representatives shall be authorised to raise any objection in this regard and if any body makes any objection the same will be treated as null and void. Hence I have rendered the aforesaid few lines in writing in the shape of a sale deed so that the same remain and serve as an authentic document whenever need arises.



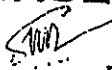

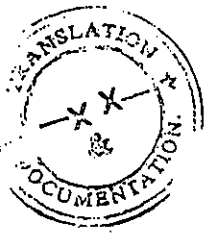
