3. I estimate Total Estimated Cost of completion of the building(s) of the aforesaid project under reference as **Rs. 7,75,00,000/-** (Total of Table A and B) at the time of Registration. The estimated Total Cost of project is with reference to the Civil, MEP and allied works required for completion of internal & external works, as per specifications mentioned in the agreement of sale and for the purpose of obtaining occupation certificate / completion certificate for the building(s) from the M.C.G.M. being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.
