Affidavit cum Declaration of Ms. MUNISH GROUP OF COMPANY promoter of the proposed project Known as

I duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as under

1. That I Ms. MUNISH GROUP OF COMPANY has a legal title to the land on which the development of the project is proposed

That seventy per cent of the amounts realized by me/promoter for the real estate project from the allotters', from time to time, shall be deposited in a separate account to be magnitained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

(b) For Ongoing project on the date of commencement of the Act

(i) That seventy per cent of the amounts realized by me/promoter for the real estate project from the allotters', from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

OR

- (ii) That entire of the amounts to be realized hereinafter by me/ promoter for the real estate project from the allotees, from time to time, shall be deposited in aseparate account to be maintained in a schedule bank to cover the cost of the construction and the land cost shall be used only for that purpose, since the estimated receivable of the project is less than the estimated cost of completion of the project.
- 5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn in proportion to the percentage of completion of the project in accordance with Rule 5.
- 6. That I/ Promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilised for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 7. That I / promoter shall take all the pending approvals on time, from the competent authorities.
- 8. That I / promoter have / has furnished such other documents as have been prescribed by the rules and regulations made under the Act.
- 9. That I / promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on any grounds.
