

DECLARATION

- I, SRI. NARSHI GOVIND PATEL partner of Limited Liability Partnership M/S. SHREE KRISHNA LIVING LLP (hereinafter referred to as the Promoter), hereby state and declare as under with regard to give necessary clarifications in respect of the registration of project known as "Navageeta" -
 - A. That the Promoter has undertaken re-development project viz.

 - B.
