AFFIDAVIT CUM DECLARATION

- 1. That the PROMOTER has a legal title Report to the Project Land, on which the development of the proposed Real Estate Project is to be carried out & a legally valid authentication of the title of such project land along with an authenticated copy of the agreement between such owner society and promoter for redevelopment of the Real Estate Project, is enclosed herewith.

- 9. That the PROMOTER has furnished all such other documents as have been prescribed by the rules and regulations made under the Act.
- 10. That the PROMOTER shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
