


FORM 'B' (Affidavit cum Declaration)

I Mr Michael Rodrigues duly authorised by the Proprieter of Emaar Enterprise, vide its authorization dated 15th July 2017.

I duly authorised by the director of Emaar Enterprise do hereby solemnly declare, undertake and state as under;

- That I have a legal Title Report to the land on which the development of the projects is proposed. I enclosed the authenticated copy of title certificate of Advocate Ramakant Arorkar dated 22nd February 2012.
- 2. I say that the details of encumbrances including dues and litigation, details of any rights, title, interest or name of any party in or over such and along with details are enclosed herewith.
