Telangana do hereby State, declare and confirm as under.

- 1. That M/s. Mahidhara projects private limited has a legal title to the land on which the development of the proposed project (MAHIDHARA PARADISE) is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owners and promoter for development of the real estate project is enclosed herewith.
- 2. That the said land is free from all encumbrances
- 3. That the time period within which the project shall be completed by M/s. Mahidhara projects private limited is 01.05.2025.



- 4. That seventy per cent. of the amounts realized by M/s. Mahidhara projects private limited shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
- 8. That M/s. Mahidhara projects private limited shall take all the pending approvals on time, from the competent authorities
- 9. That M/s. Mahidhara projects private limited has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
