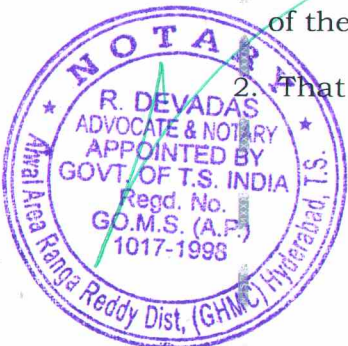

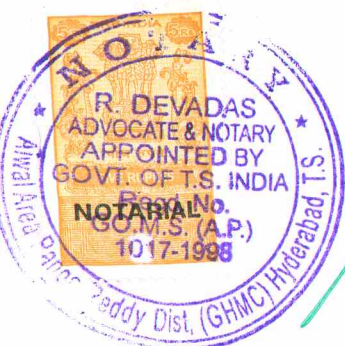
3. That the time period within which the project shall be completed by me/promoter 16/May/2024.
