- I, D.V.K.NAGENDER RAO promoter of the project do hereby solemnly declare, undertake and state as under:
- 1. That I have a legal title to the land on which the development of the proposed project is to be carried out and a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.

- 9. That I have furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
