- (1) I state that I am the authorized signatory of this project and have filed an application for registration of our project "MITHILA SPLENDOR" situated at land bearing Sy. No.26/1, measuring 1 Acre 33.5 Guntas, situated at Gullakayipura Village, Anugondanahalli Hobli, Hoskote Taluk, Bangalore Rural district, Bangalore, Real Estate Regulatory and Development Authority ('Authority')
