



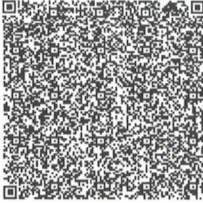

AFFIDAVIT CUM DECLARATION

Affidavit cum Declaration of Mr. Ajay S Makam, authorised representative of Century Prime Properties Private Limited, Promoter of the proposed project, vide authorization dated November 2, 2023.

9. That promoter has furnished such other documents as have been prescribed by the rules and regulations made under the Act.

10. That promoter shall not discriminate against any allottee at the time of allotment of any plot on any grounds.



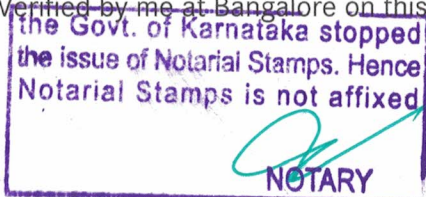

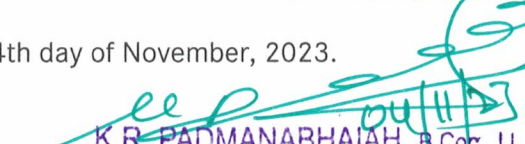
