With reference to the above, 'No Objection Certificate' from Whitefield Division, BESCOM is hereby issued for arranging power supply to an extent of 399KW(469 KVA) to the Proposed **Demostic Building** in-favour of M/s. Novolife Innovative Structures LLP, K.No.7677, Sy.No.215/6, 215/10, 215/13, 215/15&215/17, Gunjur village, Varthur Hobli, Bangalore-560066 in Varthur O&M, E4 sub division.

subject to the following conditions:

1. Power supply to your proposed **Domestic Building** will be arranged with the following arrangements.
 - a. **Regular Source:** It is proposed to tap 11KV main power supply from existing F7 Feeder of K.M. Halli MUSS passing infront of applicant premises at Gunjur main road with Rabbit conductor by providing 11 Mtr single spun pole structure with 3-Gos sets. Then it is proposed to extend 11KV line through 3X95sq.mm XLPE UG cable to a distance of 50 Mtrs with rings & rise and terminated inside applicant premises by providing 1No. of 4-Way DAS RMU with 2X500KVA Transformers with all other transformer accessories on cement bedding.
 - b. **Alternate Source:** It is proposed to tap 11KV change over power supply from the existing 2OD RMU of F11 Feeder of K.M. Halli MUSS passing through 3X400sq.mm XLPE UG cable at Gunjur main road by providing 1No. of additional VI. of DAS compatible

distance of 75 Mtrs with rings & rise and terminated inside applicant premises at proposed 4-Way RMU.

- c. Presently No LT/HT lines passing inside applicants premises and No LT/HT installations existing in the premises. Hence Submitted for your kind approval and further needful.
2. If any KPTCL/BESCOM lines are passing through the applicant's premises these shall be shifted at your cost. This NOC does not apply to the premises where EHT lines are passing through the premises for which NOC is to be obtained from the concerned authorities.
3. If any installation is existing, the same shall be surrendered by clearing all arrears before taking up infrastructure work in the premises.
4. While applying for power supply to the said Domestic Building at the above address, all regulations as per KERC conditions of supply of Distribution licensee in the state of Karnataka to be followed.
5. Power supply shall be arranged to the said Domestic Building based on the provisions of regulations of KERC is applicable at that time.
6. This "NOC" is issued only for the purpose of obtaining sanction plan for Domestic Building from BDA/BBMP/Competent authorities and is not a commitment for power sanction from BESCOM. Power supply will be sanctioned when applied for, subject to feasibility at that time.
7. The approximate load requirement of the above Domestic Building is 399KW/469 KVA.
8. This NOC is valid for a period of Two years from the date of issue. Rs. 10,000/- collected vide Rt. No. 939385625761 dtd. 24.06.2022 towards issued of NOC.
9. No LT/HT installation exists or LT/HT lines passing inside applicant's premises.
