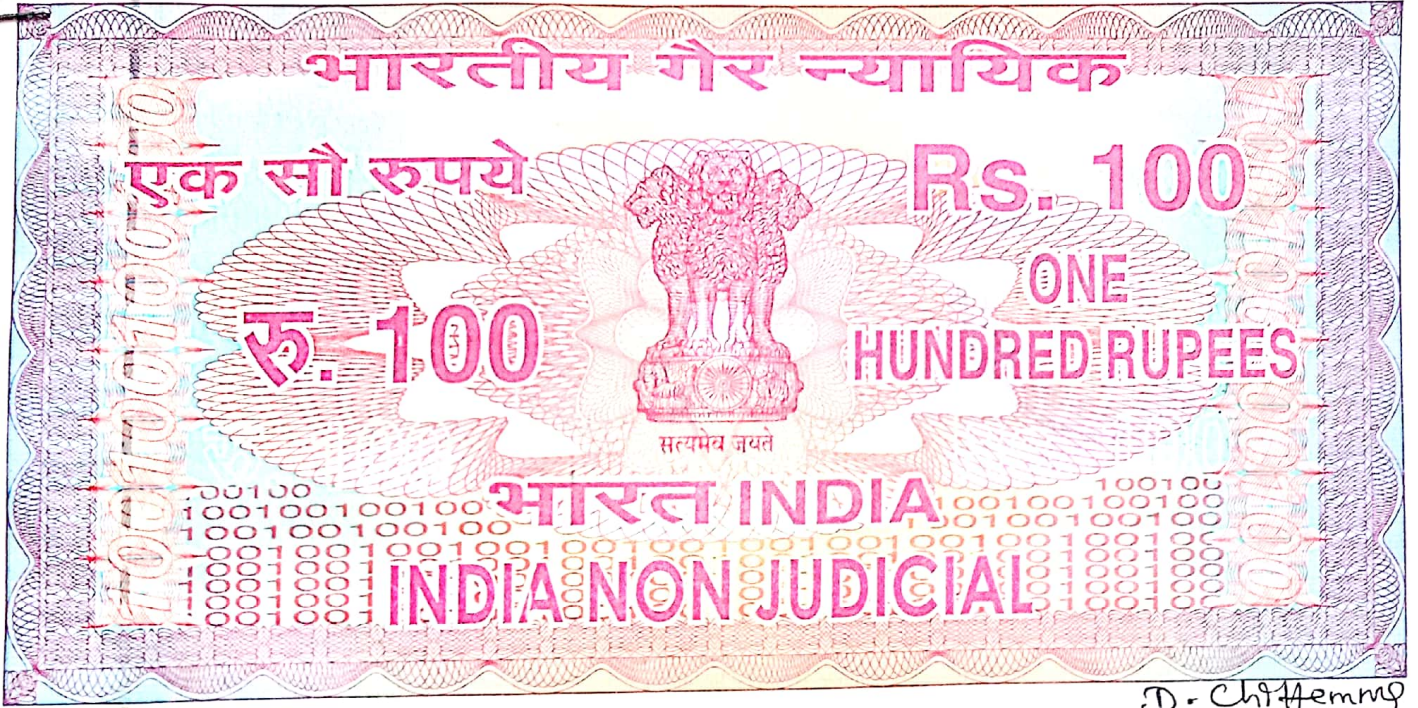

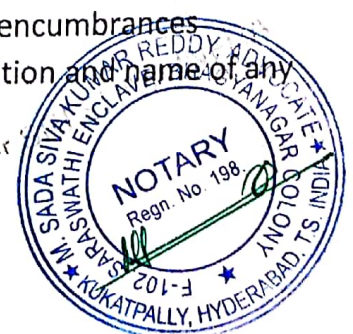

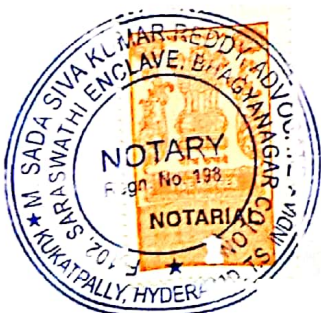
3. That the time period within which the project shall be completed by [me/The promoter] is 12-08-2026
