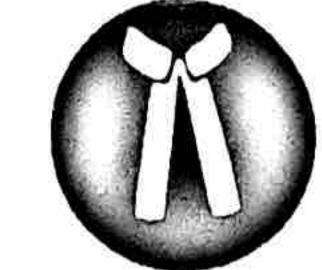

I have examined and scrutinized the documents mentioned at SI.No. 1 to 6 of the table above. Whereas M/s Vaddiraj Infrastructures Pvt.Ltd, a private limited company constituted by three directors viz., V.Vikram, V.Ganesh and V.Shyamala Devi have entered into development agreement with the land lords for an extent of 1030 Sq.yards in 13-4-20, Matwada, Warangal city by way of development agreement dated.12/01/2018 vide doc.no. 209/2018. The developers have obtained permission for the construction of apartments in stilt + Ground + 4 floors from Greater Warangal Municipal Corporation, Warangal vide proceeding no. 3006/10959/W25/2018 dated 09/05/2018. After obtaining the construction permission in an area of 1030 Sq.yards, the developer has commenced the construction work. I have also verified the encumbrance certificate mentioned at sl.no.3 of the above. There are no encumbrances over the property under development.

In View of the above documents, facts and circumstances, I am of the opinion that, title to the property of D.Ramchandher Rao and D.Rajender Kumar in plot no.13-4-20 vide municipal permission proceeding no.3006/10959/W25/2018 dated 09/05/2018 issued by the Greater Warangal Municipal Corporation, Warangal is clear, valid and marketable. The Residential apartment complex to be constructed in the above plot as per the permission of Greater Warangal Municipal Corporation, Warangal will also have a clear valid and marketable title.
