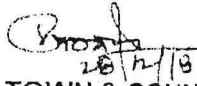

With ref. to the above subject cited, the layout proposal in Sy.No. 40,51 & 52 to an extent of Ac. 20.957 cents applied by Smt. Suheela Tivari W/o Kranti Lal & others at Namya Tanda G.P., Balanagar Mandal, has been inspected and observed following:-

1. The site is abutting to a kunta in Sy.No.50 as per touch map issued by Tahsildar, Balanagar Mandal and it requires NOC from both irrigation (not below the rank of Executive Engineer) and Revenue department (Not below the rank of Joint Collector). Hence advise the applicant to obtain the same.
2. The applicant shall submit certificate of demarcation of site by Assistant Director of Survey Land Records dept. as per layout rule 3(3) (VII) of Govt. G.O.Ms.No.67, PR&RD, dt: 26.02.2002.
3. As per the submitted plan, the total extent is not tallying and discrepancy in between submitted registered documents, Land conversion certificate, Touch map issued by Tahsildar and as per application and also not submitted Nala certificate for the Sy.No. 54. Hence clarify total extent of the site.
4. To submit village map extract & Google map duly showing the site under reference.

In view of the above, you are herewith informed to advise the applicant to submit above shortfalls for taking further necessary action in the matter.
