LIVE IN EXOTICA, do hereby solemnly declare, undertake and state as under:

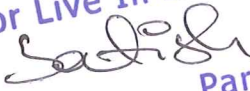
1. That we have a legal title to the land on which the development of the project is proposed and a legally valid authentication of title of such land for development of the real estate project is enclosed.

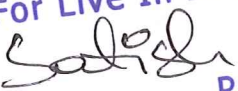
