M/s. Mypi Lush Green Rep by its managing partners i) Sri.P. Raja Shekar Reddy ii) D. Satish Kumar 2. R. Avinash, R. Ambarish, R. Rajeshwar Goud Rep by their DGPA Holder: M/S. Mypi Lush Green Rep by its managing partners: i) Sri. P. Raja Shekar Reddy ii) Sri. D. Satish Kumar. Accordingly, the Draft Layout Permit No. 000053/LO/Plg/HMDA/2021, dt. 21.01.2021 and intimated to the applicant requested to follow the condititions as mentioned in the reference 2nd read above.

The applicant has filed all relevant documents along with Mortgage deed bearing No.16926/2020, dated. 30.12.2020 for the plot No's. 1 to 6, 19 to 23, 40 to 44 and submitted to HMDA Commissioner in approved layout plan bearing file No. 0016242/MED/LT/U6/HMDA/11102018, Dt. 21.01.2021 in Sy.No's. 283, 329 and 337/A, situated at Dundigal Municipality - ORRGC (V) ,and paid the layout charges i.e., site approved fee of Rs.10,27,568/- + Layout fee Rs.1,02,700/- + Conversion Fee Rs: 5,13,784/- + Publication Charges Rs:5,000/- Total Rs.16,49,052/- through RTGS on dt.19-03-2021.

In the above circumstances, it is ordered that the final layout is released and instructed the following:

- 1. It is directed to complete the developmental works mentioned in the HMDA orders within a period of Three (3) years as per G.O.Ms.No.276, MA, dt.2-7-2010 and submit a requisition letter for release of mortgage plots/area.
- 2. It is directed that the open spaces shall be developed by you along with other developments with ornamental compound wall and grill as per santioned layout plan.
- 3. The Applicant shall develop the roads area, open space area & amenities area along with the other development works.
- 4. The layout development work consists of road formation with Black top, storm water drains, providing of underground drainage lines, internal water supply pipe lines, assured water supply source, providing electrical supply lines along with street lights, avenue plantation, park development.



- 7. If any cases are pending in court of law with regard to the site U/R and have adverse orders, the permission granted shall deem to be withdrawn and cancelled.
- 8. The applicant shall provide the STP and septic tank as per standard specification.
