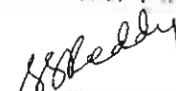

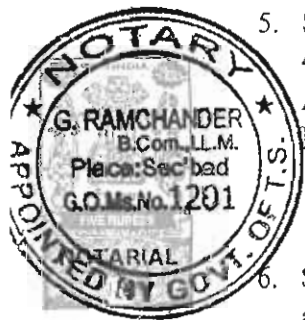

12. The net profit after debiting partners interest, salary as reflected in Profit & Loss Account drawn up on 31st of March of each year after deducting all expenses relating to the partnership business shall be divided in the following ratio among the partners:

13. That the books of account of the partnership business shall be maintained in English from 1st of April and closed on 31st of March of each year and the Balance Sheet and Profit and Loss Account shall be drawn up accordingly.
14. The Partnership firm shall continue the existing bank accounts on open bank account in its name and the same shall be operated by the Partner of the first and sixth part jointly. The firm may borrow monies from banks, financial institutions or private individuals for the purpose of its business on the strength of the signature of the partner of the second and sixth part at reasonable market rate of interest.
15. If any partner intends to retire from partnership he / she shall give atleast six months notice in writing to the other partners. No partners shall sell, gift or otherwise transfer his/her share in the partnership firm without the consent of all the remaining partners.
16. The partners shall be entitled to change, delete and to amend any clauses of the partnership deed with mutual consent.
17. In case of death or retirement or lunacy or insolvency of any one of the partner or more partners the partnership shall not be deemed to come to an end, but shall be continued by the surviving or remaining partners sharing profit and losses in respective shares.
18. In Case of any dispute between partners the same shall be referred to an arbitrator or arbitrators of the common choice of the partners and provisions of the Arbitrations Act shall apply accordingly.
19. That the Goodwill of the firm will belong to the firm and in case of dissolution of the firm the partners shall not use it unless mutually agreed.

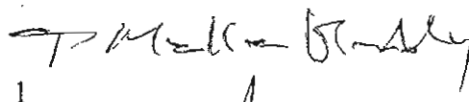

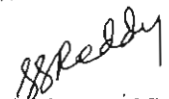
