



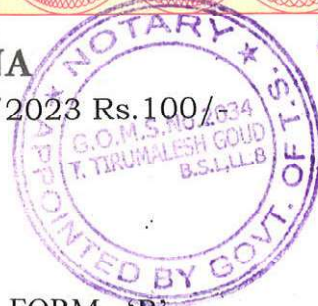

Affidavit cum declaration

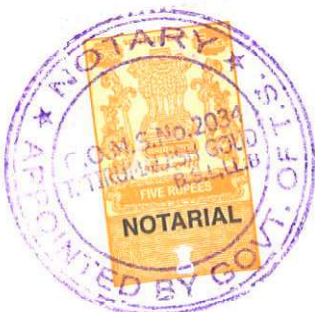
