It appears from the sale deed dated 12/10/2004 that, Mrs. Indumati Anandlal Shah, Mr. VIII. Hiralal Dahyalal Shah, Mr. Shantilal Motilal Kothari, Vijaykant Motilal Kothari (The Vendors/Landowners) with the consent of Mr. Jayprakash Sitaram Goel, Mr. Subhash Sitaram Goel, Mr. Rajendra Sitaram Goel, Mr. Umesh Sitaram Goel, Mr. Atul Jayprakash Goel, Mr. S. M. Agarwal, M/s Goel Associates (The Consenting Party) sold land admeasuring 07 Hectare 85.76 Ares out of Gat No. 2272 totally admeasuring 16 Hectare 54 Ares situated at Village Wagholi, Taluka Haveli, District Pune, (i.e. the said land which is the subject matter of present report) to Logipark Warehousing Pvt. Ltd. (The Purchaser) vide sale deed dated 12/10/2004 which is registered before sub-registrar Haveli No. 7 at Serial No. 4392/2004 dated 15/10/2004. - IX. It appears from the record that, the Ministry of Corporate Affairs issued a certificate of Registration on Conversion of Logipark Warehousing Pvt. Ltd. to Logipark Warehousing LLP dated 01/05/2015. Accordingly, the name of Logipark Warehousing LLP was recorded on the 7/12 extract vide mutation no. 11889 dated 26/11/2015.
- X. It appears from the record that, Mr. Jaiprakash Sitaram Goel and other (Party of the First Part) and M/s Logipark Warehousing LLP (formerly known as Logipark Warehousing Pvt. Ltd.) (The party of the Second Part) executed the Deed of Cancellation of right of way dated 26/12/2019, which is registered before sub-registrar Haveli No. 11 at Serial No. 22544/2019 dated 27/12/2019. According to this cancellation deed both parties cancelled right of way of 7.5 mtr. wide road entitled by them in the Gat No. 2272, Wagholi vide sale deed no. HVL-7-4392-2004, HVL-7-4394-2004.
- XI. It appears that, M/s Logipark Warehousing LLP through its Director Mr. Mayur Umeshkumar Jalan, Omprakash Madanlal Chamadia, Ishwarchand Kishorilal Goel executed Lease Deed dated 03/11/2021 for 5 years from date of registration, in respect to the land admeasuring 25 Sq.mtrs. out of the said land 07 Hectare 85.76 Ares out of Gat No. 1286 (Old Gat No. 2272), Wagholi, Taluka Haveli, District Pune; in favor of Maharashtra State Electricity Distribution Company Ltd. represented through Mr. Vijay Narsingh Jadhav, and the same is registered before sub-registrar Haveli No. 27 at Serial No. 11532/2021 on 10/11/2021.
- XII. It appears that, Hindustan Petroleum Corporation Ltd. has been given right over 32.40 Ares from the Gat No. 1286, Wagholi, Pune and High Pressure Petroleum pipeline is passing from the some portion of the said property therefore Hindustan Petroleum Corporation Ltd. has given no objection to carry out construction on the remaining area

- XIV. Revenue Record: I have inspected the Revenue Record in respect of the property from the year 1974-75 onwards. Such search has not disclosed any fact or circumstance prejudicial to the title of the said owner/promoter to the said property.
- XV. Search: I have carried out search in respect to the said land in the office of sub-registrar Haveli No. VII for the period 1993 to 2001. It is observed that all records are not maintained properly and most of the Index II Registers of this period are missing and those available for search are partly torn, pages are missing, and also not readable. During search of this type of available record, I did not come across any
