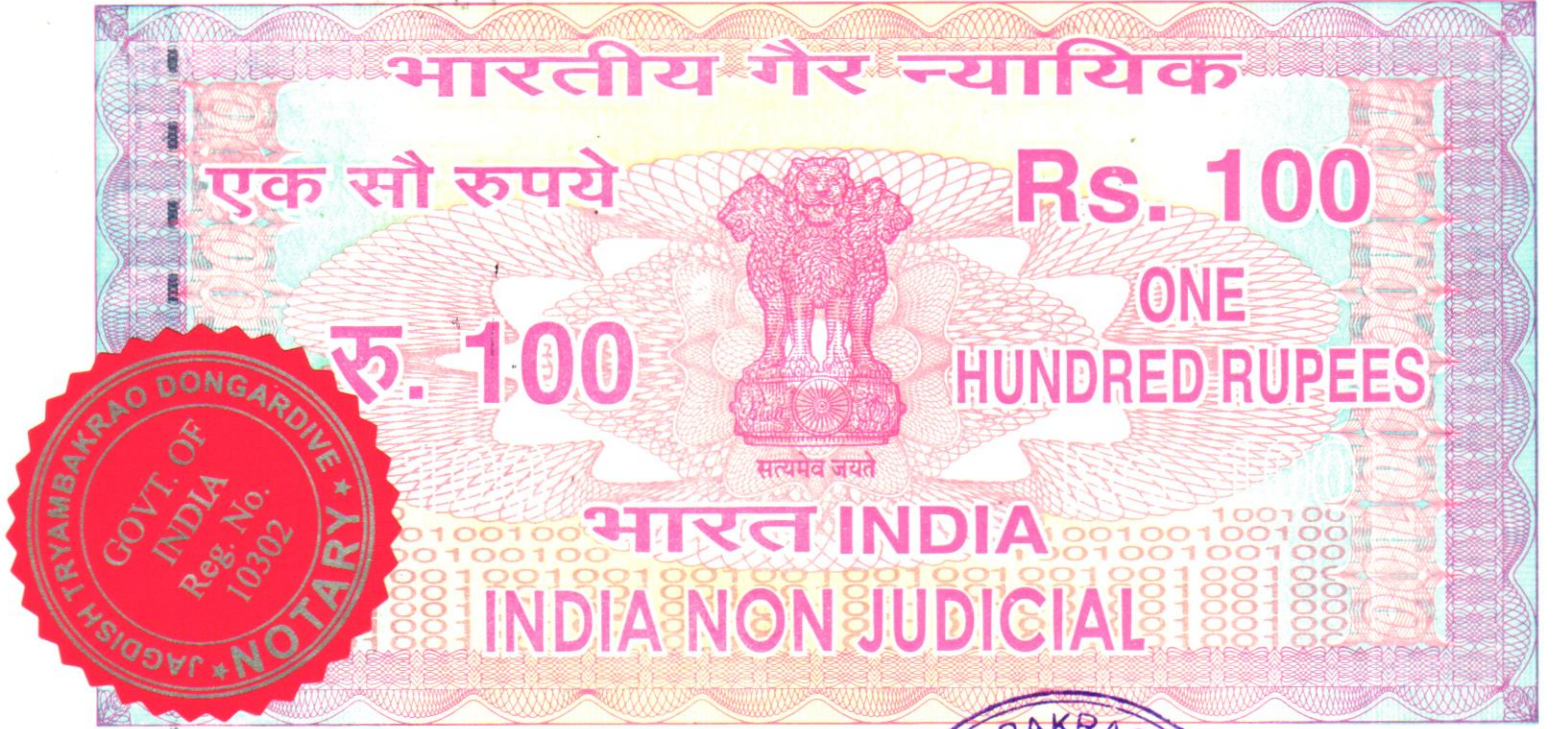

3. That the time period within which the project shall be completed by me from the date of registration of the project is **31.08.2028**.

4. 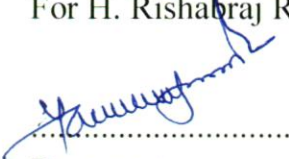
