The Perusal of the above documents reveals that Mr.Om Prakash Gupta S/o.Vishweshwaranath purchased an extent of Ac: 18-08 Cents in Sy. No: 102 of Medipally Village, Erstwhile Hyderabad Dist by way of Registered Sale deed bearing Doc: No: 2521/1967 office of the Sub-Registrar, Hyderabad East for consideration from its owner and possessor Anwarulla Pasha for consideration and obtained physical possession thereof. Thereafter, an extent of Ac: 17-24 Gts in Sy. No: 102 of Medipally Village is mutated in his favor in revenue records and patta Pass Book vide No: 00318 is issued by the Tahsildar, Hyderabad East.

That sri Mr.Omprakash Gupta died on 5-11-1991 leaving behind his sons Mr.Satya Prakash, Sri.Prem Kumar and his wife Smt Vidya Devi as evident from the Legal Heir Certificate Dt: 26-6-1992 bearing No: C/2970/92 issued by the Mandal Revenue Officer, Uppal Mandal, Ranga Reddy Dist.

Further Mr. Satya Prakash and Prem Kumar executed the GPA in favour of their mother Smt Vidya Devi vide doc No. 95/1993 registered in the office of the sub registrar Uppal in respect of the above said land. Thereafter Smt. Vidya Devi along with her two sons Mr. Satya Prakash and Mr. Prem Kumar sold for consideration an extent of 1560 sq yds and extent of 2840sq. yds in sy. No. 102, Om Vihar, situated at Medipally Village and Gram Panchayat (previously under Peerzadiguda gram panchayat), Ghatkesar Mandal, Ranga Reddy Dist by way of Sale deed bearing Doc No. 948/1996 and by way of Sale deed bearing Doc No. 950/1996 respectively to SAYAJI IRON & ENGG. CO. LTD (later changed to Mac Nally Sayaji Engg. Ltd), both the sale deeds registered in the office of sub registrar Uppal.

Thereafter Mac Nally Sayaji Engineering LTD., sold the part of open land in sy.no. 102, of Medipally village in 'OM VIHAR' situated at Medipally village and Gram Panchayat, Ghatkesar Revenue Mandal, Ranga Reddy dist., admeasuring 641 sq. yds, to Sri. K. Venkat Reddy and 4 others by way of Sale deed bearing Doc No.2305/2015 dated 10-03-2015 registered in the office of the Sub-Registrar, Uppal for consideration.

Further in pursuance of the sanctioned plan executed registered mortgage deed bearing Doc: No: 10839/2018 Dt: 4-10-2018 for the due completion of the project.

Further Xerox copy of Encumbrance Certificate for the period 1-1-1985 to 10-11-2014 issued by Sub-Registrar, Uppal and Encumbrance Certificate for the period 11-10-2016 to 12-05-2019 issued by Sub-Registrar, Narapally reflects the above said transactions. Basing on the above said documents title can be traced from the year 1967 and the title is passed through registered documents to the present owners. Further M/s ARB INFRA PROJECTS obtained required permission from the competent authority to construct the residential building Apartment.
