


AFFIDAVIT CUM DECLARATION

Affidavit Cum Declaration of **Mr. Dilip Devichand Chaudhari** having Age: 46 yrs, Occupation: Business, having office at Nisarg Plaza, Second Floor, opp. Santoshi Mata Mandir, Daınle Chowk, Akola, Promoter of the proposed project, vide its/his/their authorization that,

- I, The promoter of the proposed project do hereby solemnly declare, undertake and state as under:
 - 1. That I have a legal Title report of the land on which the development of the proposed project is to be carried out and a legal valid authentication of title of such land along with an authenticated copy of the sale deed of the real estate project is enclosed herewith.
 - 2. That the project is free from all encumbrances.

- 7. That I shall take the pending approvals on time, from the competent authorities..
- 8. That I shall inform the authority regarding all the changes that have occurred in the information furnished under sub-section (2) of section 4 of the Act and under Rule 3 of these rules, within seven days of the said changes occurring.
- That I have furnished such other documents as have been prescribed by the rules and regulation made under the Act.
- 10. That I shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be.
