 - d. Premium towards staircase, lift and lift lobby area.
 - e. Labour Welfare Cess.
 - f. Fungible premium.
- 4. That the N.O.C. from MHADA mentioning builtup area to be surrendered to MHADA if any shall be submitted before asking for further C.C. and such builtup area shall be marked on plan and plans shall be got amended for this office.
- That the final N.O.C. from C.F.O. shall be submitted before asking for Occupation permission.
- That the drainage layout shall be revised and be got approved from this
 office before carrying out further drainage work.
- That the final N.O.C. from MHADA shall be submitted before asking for occupation permission to sale component of building.
- That additional water & extra sewerage charges shall be paid before asking plinth C.C.

- That the final N.O.C. from Tree Authority shall be submitted before asking for Occupation permission.
- 10. That the work shall be carried out strictly as per approved plan.
- That the final structural stability certificate shall be submitted before asking for B.C.C./ Occupation.
- 12. That the R.L. shall be got demarcated and Regd. Undertaking stating to hand over the setback land free of cost to M.C.G.M. before granting the C.C. above 50% of proposed area and transfer the same in the name of M.C.G.M. before granting full C.C.
- 13. That the N.O.C. from Inspector of Lifts (P.W.D.) shall be submitted.
- 14. That the vermiculture bins for the disposal of wet waste as per design and specification of organization or companies specialized in this field as per list furnished by solid Waste Management of M.C.G.M. shall be provided.
- 15. That the provision of Rain Water Harvesting as per the diagram proposed by approved consultant in the filed shall be made in the satisfaction of Municipal Commissioner shall be provided.
- That Registered Undertaking for handing over setback area for the balance portion of the plot not covered under this proposal as and when required by M.C.G.M. shall be submitted.
- That the land so kept for reservation of P.G. and the plot boundary shall be demarcated from D.I.L.R. / C.S.L.R.
- That an area of 222.54 Sq.Mt. of P.G. shall be handed over to M.C.G.M. as earmarked on the plan & separate P.R. Card of R.G. plot in the name of M.C.G.M. as per D.P. Release under No.CHE/23630/D.P./City dated 21/11/2013 shall be submitted before O.C.
