With reference to the above subject proposal, No objection Certificate is hereby issued for arranging power supply to an extent of 1950 kVA in favour of Goyal Hariyana Enterprise, No.8/16/2, Sy.No :16, Thirumenahalli (V), Yelahanka (H), Bangalore in O&M 20A, C-8 Sub Division, Hebbala Division under Self Execution subject to the following conditions:

 You shall make power supply arrangements as follows: Main Source - Proposed new feeder from Arkavathi upcoming MUSS by using 3x400sqmm HTUG cable to a distance of 5.6 kms.

Alternate Source - Proposed to tap existing F11 feeder emanating from 66/11 kV Shobhacity MUSS to a distance of 0.5 mtrs near double road, Thirumenahalli.

- 2. The validity of NOC is for two years from the date of approval letter as per the decision of the 46th TCC meeting held on 7-9-2009 and the power supply position will be reviewed at the time of sanctioning regular connectivity.
- 3. The 11 kV distribution network shall be executed as per BESCOM standards practice.
- 4. The validity of NOC is for two years from the date of this approval letter and the connectivity will be reviewed at the time of sanctioning regular connectivity.

Metering details for the said EHT installation shall be communicated based on the fract demand when approached for regular connectivity.

- 6. If your requirement exceeds 7500 KVA, you shall commission a 66/11 kV MUSS in your premises under self execution. You shall leave vacant land/space of about 50 mtsX 80 mts for this purpose without constructing any building and the same shall be earmarked in the approval plan.
- BESCOM in any way is not responsible for any kind of problems that may arise due to this NOC.
- If any KPTCL/BESCOM Lines pass inside the consumer's premises, the proposed consumer himself is liable to shift them as per BESCOM norms at his own cost.
- Proposal for power sanction in future which may come in the said applicant's premises, the regular and alternate source will be provided based on the technical feasibility report at that time.
- 10. In future, at the time of applying for Power supply in the said premises, the consumer shall mandatorily follow the prevailing KERC/BESCOM Rules and Regulations without fail.
- Power supply will be arranged based only on BESCOM norms, to any various buildings that may come up in future inside the consumer's premises.
- 12. The purpose of issuing this NOC is only to obtain sanctioned plan from BDA or BBMP or any other Competent Authorities and this is not a binding on BESCOM for arranging power supply. Power supply will be arranged in future based only after reexamining the latest Technical feasibility as per BESCOM norms.
