Your application dated Nil regarding fire safety measures.

Sir.

With reference to the above, you are requested to implement the following minimum Fire Prevention and fire safety measures in the proposed (BLOCK A - G + 8 STORIED AND BLOCK B - G + 2 STORIED) RESIDENTIAL BUILDINGS mentioned above at the above noted location for safety of lives and properties as well as the building itself.

After proper implementation of the following fire safety measures Fire Safety No Objection Certificate may be considered.

. All parameters relating to height, occupancy etc. shall be as per planning permit duly accorded by GMDA, Guwahati vide No. GMDA/PP/0123/28052021/28 dated 28.05.2021. Moreover conditions laid down there shall also be followed. Setback/Driveway:-

- The required setback provision around the Block A: North 14 m, West 9 m and East
- b. The Setback provision around the Block B is to be provided as per approved planning
- The gap atleast 6 mtrs. is to be maintained between the blocks and parking/parking shed or any kind of obstruction are to be strictly prohibited around the buildings' premises.
- At least 3 (three) Nos. of water drum of 500 ltrs. capacity each should be made available in the
- A Fire Point consisting of 3 (three) Nos. Fire Bucket, 3(three) Nos. of Fire Beater, 1 (one) No. ceiling hook and dry sand should be made available in the construction site.
- At least 5 (five) Nos. Portable Fire Extinguishers of dry chemical Powder of 4 kg. capacity should Passageway and clearances:-

- (a) Width of main entrance of the premises shall be not less than 6 mtrs.
- (b) If an arch or covered gate is constructed, it shall have a clear head-room of not less than 5 mtrs.
