### III. COMMENTS ON THE DOCUMENTS EXAMINED:

1. On the examination of the above mentioned documents, it is observed that immovable properties bearing Survey No. 116, measuring 1 Acre 26 Guntas, Survey No. 117, measuring 1 Acre 4 Guntas, Survey No. 119/2 (old no. Survey No. 119), measuring 1 Acre 30.08 Guntas, situated at Hulimangala village, Jigani Hobli, Anekal Taluk, Bangalore and Survey No. 4/2, measuring 0.12 Guntas situated at Nanjapura village, Jigani Hobli, Anekal Taluk, Bangalore, are agricultural properties. The flow of title in respect of the Properties are mentioned below:

Re: Survey no. 116, measuring 1 Acre 26 Guntas and Survey No. 117, measuring 1 Acre 4 Guntas:



- 2. Originally, Survey no. 116, measuring 1 Acre 26 Guntas and Survey No. 117, measuring 1 Acre 4 Guntas belonged to Mr. Thimmaiah son of Muneppa, having acquired the same by way of inheritance, as gathered from Index of Land records and Record of Rights bearing no. 193 and 194.
- 3. Record of Rights bearing no. 893 and 894 read with Mutation Register Extract bearing MR No. 23/57-58 records that based on an application made by Mr. H T Narayana Reddy, son of Thimmaiah, the khata was transferred in his name in respect of Survey No. 116 and 117.
- 4. We have been furnished with genealogical tree of Late Mr. Thimma Reddy son of Nadubeedi Thimmaiah dated 03.07.2013 which reflects that Late Thimma Reddy was married to Late Mrs. Eeramma and they had 4 children, namely,
  - a. H T Narayana Reddy (dead) married to Sundaramma and they have one son, Narendra Babu, who is married to Gajalakshmi
  - b. H T Pilla Reddy is married to Papamma
  - c. H T Sidda Reddy is married to Munitayamma
  - d. HT Rama Reddy is married to Jayamma

We have not been furnished with death certificate of Thimma Reddy, Eeramma and H T Narayana Reddy. It is observed that the genealogical tree records the name as Thimma Reddy, whereas the revenue records the name as Thimmaiah. It is recommended to obtain an affidavit confirming that they are one and the same person.

5. Upon the death of Mr. Thimmaiah, the property was inherited by his legal heirs, namely, Mrs. Eramma, H T Narayana Reddy, H T Pilla Reddy, H T Sidda Reddy and H T Rama Reddy. On 06.04.1968, the said legal heirs have entered into a memorandum recording the oral partition between the family members pertaining to all the joint family properties, including Survey No. 116 and 117. As per the said memorandum, Survey No. 116 and 117 fell into the share of Mr. H T Narayana Reddy.



- 6. Mr. H T Narayana Reddy, son of Mr. Thimma Reddy sold Survey No. 116, measuring 1 Acre 26 Guntas and Survey No. 117, measuring 1 Acre 4 Guntas in favour of Mr. Doddalakkappa vide Sale Deed dated 10.03.1988.
- 7. Mr. Doddalakkappa along with his family members sold Survey No. 116 and Survey No. 117 in favour of Mrs. N G Nirmala vide Sale Deed dated 18.01.2006. The said sale transaction was mutated in the revenue records vide Mutation Register Extract bearing MR No. 53/2005-06.
- 8. Mrs. N G Nirmala executed an exchange deed dated 04.12.2006 wherein property bearing Survey No. 116 and Survey No. 117 were exchanged and conveyed to Mrs. Dhanalakshmi. The said transaction was mutated in the revenue records vide Mutation Register Extract bearing MR No. 86/2006-07.
- 9. Mr. H R Srinivasa Reddy, Mr. H R Shekar Reddy, Mrs. Shamalamma, Mrs. Meenakshi, (daughters of Mr. H T Rama Reddy), represented by POA Holder, H R Srinivasa Reddy (as per unregistered Power of Attorney dated 22.02.2007) executed Deed of Confirmation dated 23.02.2007 in favour of Mrs. N Dhanalakshmi confirming her ownership in respect of Survey No. 116 and 117, as they had not joined in Sale deed dated 28.06.1988.
- Mrs. N Radhika, daughter of Nagaraj and Mr. N Hemanth Kumar, son of Nagaraj executed an unregistered general power of attorney dated 23.06.2007 appointing Mrs. N Dhanalakshmi as their attorney in respect of Survey No. 116 and 117.
- 11. Mrs. Dhanalakshmi along with her family members sold Survey No. 116 and Survey No. 117 in favour of Mr. Muni Reddy and his family members vide Sale Deed dated 25.06.2007. The said sale transaction is mutated in the revenue records vide Mutation Register Extract bearing MR No. 3/2007-08.
- 12. Mr. Muni Reddy and others entered into an Agreement to Sell dated 06.09.2013 agreeing to convey Survey No. 116 and Survey No. 117 in

  - b. H T Pilla Reddy is married to Papamma
  - c. H T Sidda Reddy is married to Munitayamma
  - d. HT Rama Reddy is married to Jayamma

We have not been furnished with death certificate of Thimma Reddy, Eeramma and H T Narayana Reddy. It is observed that the genealogical tree records the name as Thimma Reddy, whereas the revenue records the name as Thimmaiah. It is recommended to obtain an affidavit confirming that they are one and the same person.

- 22. Upon the death of Mr. Thimmaiah, the property was inherited by his legal heirs, namely, Mrs. Eramma, H T Narayana Reddy, H T Pilla Reddy, H T Sidda Reddy and H T Rama Reddy. On 06.04.1968, the said legal heirs have entered into a memorandum recording the oral partition between the family members pertaining to all the joint family properties, including Survey No. 119. As per the said memorandum, Survey No. 119, measuring 1 Acre 30.08 Guntas fell into the share of Mr. H T Narayana Reddy.

We observe that the RTCs for the period 1989-90 to 1996-97, 2012-13 to 2021-22 reflect that there is 15 year non-alienation period in respect of the property. It is observed that the Inam regrant order was passed on 12.04.1982. Therefore, the period of 15 years has lapsed in the year 1997. It is recommended to get the entry of non-alienation period removed from the revenue records.

- 46. The Form 10 reflects that Survey No. 4 is phodied into two portions, i.e. Survey no. 4/1 and 4/2. Portion measuring 4 Acre 10.04 Guntas held by N R Nagaraja Rao was numbered as Survey No. 4/1 and portion measuring 0.12 Guntas held by Kodandarama was numbered as Survey No. 4/2.

### **Mortgage**:

- 47. We gather from Record of Rights bearing RR No. 193, 1060, 1068 and 1073 that the Properties were mortgaged. We have not been furnished with the mortgage deed or discharge deed thereof.
- 48. We have not been furnished with the discharge deed thereof. We note that Limitation expired has expired. Hence, we are not insisting on the same.

Mutation Register Extract bearing MR No. 1/54-55 reflects that Narayana Reddy son of Thimmaiah has mortgaged Survey No. 119, measuring 3 Acres 21 Guntas in favour of Rural Industrial Co-operative Society Limited. Subsequently, the said mortgage was assigned and the same is recorded vide Mutation Register Extract bearing MR No. 4/54-55.
- 50. H T Narayana Reddy and others executed a Mortgage Deed dated 04.05.1960 in favour of Land Mortgage Co-operative Society, Anekal in respect of Survey No. 116, 117 and 119. Mortgage Deed/Assignment deed dated 06.05.1960 executed by Land Mortgage Co-operative Society in favour of Mysore Central Co-operative Land Mortgage Bank. The said mortgages were discharged by way of Discharge Deed dated 02.07.2013 and 30.07.2013.
- 51. Mutation Register Extract bearing MR No. 7/76-77 reflects that Mr. H T Narayana Reddy has mortgaged Survey No. 116 in favour of LSCS Bank.
- 52. Handicrafts Industrial Co-operative Society executed Discharge Deed dated 20.07.2015 in favour of H P Thimma Reddy, H N Manoj Kumar, H S Ganesh and H R Srinivas Reddy in respect of Survey No. 116 and 117. The said deed records discharge of mortgage deed dated 20.08.1954.

### Common flow:

- 53. Mr. Munireddy and other along with owners of adjacent properties executed Sale Deed dated 26.09.2014 in favour of Mr. S M Abubakar, (i.e. Vendor herein) in respect of various properties, including Survey No. 116 and Survey No. 117. The revenue records were mutated in the name of the Vendor vide MR No. H29/2014-15.
- 54. We observe that the last page of the original sale deed dated 26.09.2014 is missing. Therefore, Mr. Abubakar had issued a public notice dated 18.05.2022 in Kannada Prabha and Indian Express.
- 55. Mr. Abubakar Syed Mohamed conveyed Survey No. 116, 117, 119/2 and 4/2 in favour of H R Ravichandra by way of Sale Deed dated 22.03.2022.



The family members of Mr. Abubakar Syed Mohamed, i.e. wife, Mrs. Arshiya Sultana and children, Umme Ayam Hussain and Syed Mohamed Mannaan have joined as confirming parties to the sale deed to morefully conveyed the Properties. Further, Mr. H P Rajagopala Reddy, an unregistered agreement holder has joined as confirming party to the sale deed.

- 56. We have been furnished with memorandum/endorsement dated 12.09.2014 bearing No. LRF Column (80)/J/CR/01/13-14 issued by Assistant Commissioner, Bangalore South under Section 80 of Karnataka Land Reforms Act, 1961 for purchase of the Properties. The memorandum states that in case the purchaser discontinues agriculture within a period of five years, the land will be vested with the Government.

- 58. We have been furnished with endorsement dated 21.03.2007 bearing no. LRF/CR/2090/2006-07 issued by Special Tahsildar, Anekal stating that stating that no tenancy proceedings have been filed in respect of Survey No. 116, 117 and 119.
- 59. We have been informed that there are no litigations pending in respect of the Properties.
- 60. We have been furnished with the Change of Land Use Order dated 31.01.2013 bearing No. BDA/NYS/CLU-08/2972/2022-23 issued by Bangalore Development Authority stating the land usage of the properties in Survey Nos.116, 117, 119/2, 120/2, 120/3, 120/4 all situated at Hulimangala Village and Survey No.4/2 situated at Nanjapura Village, is changed from agricultural zone to residential purposes.
- 61. On an application made by H.R. Ravichandra, and payment of necessary fee, the Properties were converted from agricultural to non-agricultural layout-residential purpose vide the following conversion orders:
