Sub:- Issue of NOC for arranging power supply to an extent of 280KW to the proposed residential Apartment in favour of Sri. H.V. Ventakteshaiah and Arasappa, GPA M/s. Suguna Builders & Developers, Sy No.100/4, Halagevaderahalli, Kengeri Hobli, Bangalore in W7 Sub Division.

With reference to the above, NOC is here by issued to the proposed residential Apartment in favour Sri. H.V. Ventakteshaiah and Arasappa, GPA M/s. Suguna Builders & Developers, Sy No.100/4, Halagevaderahalli, Kengeri Hobli, Bangalore in W7 Sub Division to an extent of 280KW subject to the following conditions:-

- Regular Power supply will be arranged from the existing F7 feeder of RR Nagar MUSS by way of executing under Self Execution basis by Providing 250KVA oil type Transformer with RMU.
- You have to produce an undertaking for land measuring 50mtrs x 60mtrs in your
  premises for establishing a 66/11kV MUSS at free of cost to KPTCL/BESCOM in case
  future load exceeds 4000 KVA and to establish the MUSS under self-execution, if the
  load exceeds 7500 KVA
- You have to carry out all necessary works on self-execution basis as per the estimate to be prepared by BESCOM under self-execution and necessary supervision charges on 10% of the total cost of estimate has to be paid.
- 4. While applying for power supply to the said premises, all rules as per "Conditions of supply of Electricity of Distribution Licensees in the State of Karnataka" issued by KERC shall be observed.
- 5. You have to obtain approval from the Electrical inspectorate Govt. of Karnataka and same should be furnished while availing power supply if necessary.

- 6. This NOC is issued only for the purpose of obtaining sanction of plan from BBMP/ competent authorities and is not a commitment for power sanction from BESCOM. The power will be sanctioned subject to feasibility and as per rules prevailing at that time.
- 7. The existing LT installation if any have to be surrendered before taking up the infrastructure work of the proposed residential Layout.
- 8. If any KPTCL/BESCOM lines are passing through the above premises the same shall be shifted at your cost.
  - 9. BESCOM shall not be held responsible for any liability arising from the issue of NOC.
  - 10. This NOC shall be produced at the time of availing permanent power supply to the above building.

The validity of this NOC is for a period of Two years only.
